

## Food & Beverage Benchmark COMPANY SCORECARD 2023

### **SUMMARY**

Costco Wholesale Corp. (Costco), an American multi-national food and sundries retailer among the top ten largest retailers globally, ranks 14 out of 60. Compared to 2020, the company improved its performance by disclosing details on its human rights risk assessment process, aspects of its purchasing practices, responsible recruitment efforts and remedy outcomes for workers. The company demonstrated stronger performance on the theme of Responsible Recruitment, providing details of how it supports responsible recruitment in its supply chains. However, it does not disclose a recruitment fee policy which incorporates the Employer Pays Principle, nor how the policy is implemented. The company demonstrated weaker practices on supply chain tracing, as it does not disclose a first or second tier supplier list. It also performs poorly on the theme of Worker Voice, where it did not disclose engaging with unions to support freedom of association within its supply chain, and Remedy: the company did not disclose remedy outcomes for workers.

The company is encouraged to improve its performance and disclosure on the themes of Traceability & Risk Assessment, Worker Voice, and Remedy.

### **LEADING PRACTICES**

#### OPPORTUNITIES FOR IMPROVEMENT

**Traceability & Risk Assessment:** The company is encouraged to demonstrate a strong understanding of its supply chains by disclosing the names and addresses of its first-tier suppliers (either across high-risk commodities or across all first-tier suppliers), the names and locations of below-first-tier suppliers, and a full list of raw material sourcing countries from which it sources commodities at high risk of forced labour.

**Worker Voice:** To support collective worker empowerment, the company is encouraged to work with local or global trade unions to support freedom of association in its supply chains. Further, the company is encouraged to disclose examples covering different supply chain contexts of how it improved freedom of association and/or collective bargaining for its suppliers' workers, such as migrant workers. The company is also encouraged to disclose the percentage of suppliers' workers covered by collective bargaining agreements. To guarantee protections for supply chain workers on freedom of association and collective bargaining, the company may consider entering into a global framework agreement or enforceable supply chain labour rights agreements with trade unions or worker organisations.

**Remedy:** The company may consider establishing a process to ensure that remedy is provided to workers in its supply chains in cases of forced labour and disclosing details on this process, such as responsible parties, approval procedures, timeframes, and, crucially, engagement with affected stakeholders. To demonstrate to its stakeholders that it has an effective remedy process in place, the company is encouraged to disclose examples of remedy provided to its suppliers' workers,
